The Major Companies Group (MCG) of the BusinessNZ Network is an exclusive group of 170 of NZ's largest companies. With MCG membership, major companies receive targeted services and unique opportunities to advocate for a better NZ. Benefits include premium events, policy forums delivering insights and learnings, and high-level networking and advocacy opportunities:

CEO Forum – This influential Forum meets three times a year for private exchange of insights with decision-makers including the Prime Minister, senior Ministers, Opposition Leaders and heads of key agencies. CEO Forums are confidential to allow frank advocacy and exchange of views at the highest level.

Private dinners for small groups, hosted in major cities and the regions once a month, provide Members with opportunities to discuss their business and the regional and national economy with senior Ministers and Opposition MPs.

CEO dinner with Prime Minister – An invitation to attend an annual CEO-only dinner with the Prime Minister and caucus, with pre-dinner cocktails hosted by BusinessNZ.

Corporate Affairs Forums – Corporate Affairs Forums held in Auckland and Wellington five times a year, enable senior executives from major companies to have two-way discussions with politicians and senior officials involved in work on issues important to business and the economy. Corporate Affairs Forums provide a platform for business to discuss policy and challenges, and help integrate policy directions formed at CEO level into all levels of MCG member businesses.

Premium events – Invitations to significant events including the Pre-Budget lunch in Wellington and the Prime Minister's End of Year Review in Auckland, and ongoing invitations to official trade delegation and industry events.

Demand-based Forums – Based on member guidance, MCG Forums may be held on key emerging issues important to major companies in NZ e.g. Health Forums begun during Covid lockdowns, now advise on issues such as DHB and Pharmac changes and continue to evolve.

Networking caucuses – Networking opportunities with MPs from Coalition parties National, ACT and NZ First and opposition parties

Cocktail parties – including BusinessNZ's Back to Business cocktails, the networking event most heavily attended by politicians and leading business figures.

Briefings – with Treasury, MBIE, GSCB, Commerce Commission, Reserve Bank, MFAT and other key agencies based on Member demand, at least twice a year.

Policy access – Access to BusinessNZ research, surveys, submissions and updates and access to BusinessNZ's expert policy team for MCG issues.

Partnerships – MCG Members partner with BusinessNZ on surveys, research, conferences and events, allowing Members to contribute to major policy work while showcasing their brand to stakeholders. Trade delegations - MCG Members can take part in outward-bound delegations and in events with visiting delegations, assisting international engagement and export sales.

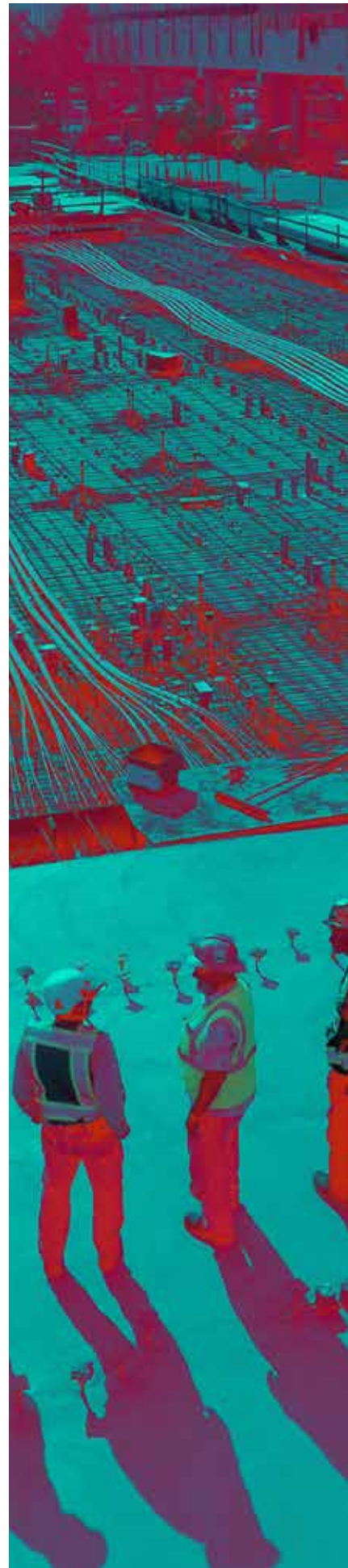

Health Forum – Focuses on changes to health legislation such as Pharmac, DHB reform, medicines and disease treatment, mental wellbeing and Health & Safety

Chief Technology Officers Forum - Discussions and influence around science, tech and innovation

Chief People Officers Forum – Keeps an eye on changes to employment law and on proposed employment policies proposed by opposition parties

Corporate Affairs Forum – Senior managers meet with lawmakers both Ministers and officials on a regular basis to engage on upcoming legislation
